Changes to the classification for Ninth Edition were sourced from: updates to WHO ICD-10; revisions to the Medicare Benefits Schedule (MBS) and the Australian Schedule of Dental Services and Glossary: and Australian Consortium for Classification Development (ACCD) tasks, including public submissions and coding queries.

Clinical and technical advice for Ninth Edition content was provided by members of the ACCD ICD Technical Group (ITG), the Clinical Classifications Advisory Group (CCAG) and ACCD's Principal Clinical Advisor in conjunction with various specialist clinicians.
